**INTRODUCTION:** The Sindh Textbook Board (STB) was established through the Sindh Textbook Board Ordinance No. XII of 1970. The core objectives of Sindh Textbook Board (STB), inter alia, to develop textbooks in accordance with the Curriculum approved by Curriculum council, and subsequently provided by Directorate of Curriculum assessment and Research, Sindh (DCAR) to print / supply textbooks from class Kachi to X, FREE OF COST, to the students studying in public sector schools under administrative control of Education & Literacy Department, Government of Sindh. In order to achieve the objective / goals, the Sindh Textbook Board (STB) provides the textbooks to all Public Sector Schools and other affiliated / allied schools of Sindh province before the start of academic session / year. The services of most suitable printers / publishers firms, in this regard, are contracted out through a transparent procedure in accordance with the procurement rule laid down under SPPRA Rule 2010 (amended 2019). In view of the above, Sindh Textbook Board (STB) invites / solicits the sealed bids from the prospective National and International firms or consortium / joint ventures, who fulfill the eligibility criteria laid-down in SPPRA Rules 2010 (amended 2019) for printing, binding and supply of Textbooks for class katchi to X for the academic session 2020-2021.

### ELIGIBILITY CRITERIA:-

- I. All the bidders / suppliers, whether be National or International, must be registered with the relevant authorities of Pakistan. SEC:29/30 of SPP Rules 2010 amended 2019 shall be applicable to all the bidders / Suppliers. However at the time of bid documents submission, they must provide relevant documents showing their valid registration with the authorities.
- II. Audited annual financial statements of last three years.
- III. Minimum five years experience in relevant field of printing and publication SEC:27(2)(a) of SPP Rules 2010 amended 2019.
- IV. Minimum Average annual financial turnover of PKR. 30 million in last three years SEC:27(2)(c) of SPP Rules 2010 amended 2019
- V. Affidavit that the firm is not blacklisted by any public or private organization SEC:29(b) of SPP Rules 2010 amended 2019.
- VI. Photocopy of bid security pay order (without showing amount on cheque) along with Technical Proposals. Prospective firms must provide valid evidence against each of above criteria. The STB reserves right to cross verify any document (s) and conduct manufacturing site visit if deemed necessary in order to ensure reliability of information and capability of service provider. Documents received without concrete evidence will be marked as disqualified during preliminary evaluation of proposals.

Bidding documents can also be obtained from the office of Secretary Sindh Textbook Board against Pay order / demand draft amounting to **Rs.5000/- or US\$ 50** (Non refundable) in favour of Sindh Textbook Board Jamshoro. In case, the bid Documents are downloaded from the website then at the time of bid submission the pay order, (Non refundable) must be enclosed along with technical proposal. All bids must be submitted in one best option under Rule-46(2) of SPP Rules 2010 amended 2019 Single Stage Two Envelope Procedure Specified.

Under, SPP Rules, 2010 amended 2019, envelope shall contain Technical Proposal and Financial Proposal Sealed separately. Financial proposal must contain original copy of pay order / demand draft i.e. **5%** bid security (refundable) of total bid cost in favor of Sindh Textbook Board Jamshoro. Any bid found without bid security of less than **5%** of total bid cost shall be rejected during or after technical evaluation. All bids along with requisite documents as mentioned in bidding document shall reach in the sealed envelope marked as Printing binding and supply of textbooks to the below given address not later than **12:00 Noon on Friday 22nd November 2019**. Sealed envelope will be opened on the same date at **03:00 p.m.** by the STB's notified Committee as per SPP Rules 2010 amended 2019. The procuring agency may reject any bid subject to relevant provisions of SPP Rules 2010 amended 2019 and may cancel the bidding process at any time prior to the acceptance of a bid or proposal as mandated under Rule-25(1).
